

Safeway Summer Central - Table 1 Project #306470



This is a multi-vendor Safeway event executing on Saturday, June 8th from 11am-5pm. There will be 2 other tables set up in addition to yours. One of the additional tables will feature Pringles and Keebler Fudge Stripe OR Nutri-Grain Fruit Crunch. The other table will feature Lay's Wavy Roasted Garlic and Sea Salt Chips (see the last page of this manual for further details). You will be managing the Hellmann's/Best Foods Mayonnaise and Capri Sun table for this event.

Please follow the instructions in this manual on how to properly execute this event:

- 1. Make a pre-call to your store 3 days prior to the event to confirm the date that you will be coming in and the products that you will be sampling. If the store states that they do not have product or if they advise that they do not want the demo, you will still go to the event as planned!
- 2. Arrive on time for your demo. Introduce yourself to the store manager and ask for assistance in where you should set up your table. Set up your table as shown on page 2 of this manual. Create an attractive display on your table with the featured products from the shelves. You may keep additional product underneath your table and replenish inventory on your table to sell, as needed. <u>Please only keep the packaging for Hellmann's/Best Foods Mayonnaise</u> and Capri Sun on your table, as these are the brands that we are promoting. All other packaging (sour cream, chips & Lipton mix) should be out of view and under the table. If customers inquire about the recipe for the onion dip, it is ok to share the other ingredients/brands used at that time.
- 3. Purchase the items in the shopping list on page 2. Verify that the UPC codes on the packages match the UPC codes in the shopping list (where applicable). Set up your pop-up cooler and fill with ice (instructions on how to set up the pop-up cooler can be found on page 5). Place the mayonnaise, sour cream and as many Capri Sun pouches that will fit inside your cooler with ice. You will keep the remaining Capri Sun pouches under your table and add additional pouches to the cooler as space is made available throughout the event.
- 4. To sample the Hellmann's/Best Foods onion dip recipe: In your mixing bowl, combine 16 oz. sour cream, 1/2 cup Hellmann's Real Mayonnaise OR Best Foods Mayonnaise (use the 4oz soufflé cup that is included in your kit to measure out 1/2 cup. [1] 4oz soufflé cup is equal to [1/2] cup) and 1 envelope of Lipton Recipe Secrets Onion Soup & Dip Mix. Stir until thoroughly mixed. Place 3 chips on a paper plate. As consumers approach, add a teaspoon size amount of the dip to the plate with the chips and hand the sample to the consumer (do not add dip to the plate prior to a consumer interaction, as the dip may seep through the plate). You should make this recipe 3 times throughout the event. Your sample distribution goal is approximately 125 samples. Your goal is to sell at least 35 containers of Hellmann's/Best Foods Real Mayonnaise.
- 5. To sample Capri Sun Big Pouch Fruit Punch: Twist off the cap of a pouch and pour approximately 2 oz. of juice into a drinking cup. Arrange samples neatly on your table. Your sample distribution goal for Capri Sun Big Pouch Fruit Punch is approximately 125 samples. Your goal is to sell at least 35 pouches of Capri Sun Big Pouch Fruit Punch.
- 6. Actively engage approaching consumers and offer them a sample. Use enthusiasm to recite the product features and benefits and to get the consumers excited about the products you are promoting. Replenish samples as needed.

The following Pre-Demo Checklist must be completed prior to your event:


Read and understand <u>all</u> of the information in this training manual.

- □ Review your kit contents for accuracy.
- Conduct your pre-call to the store 3 days before your demo and ask the grocery manager if the product is in stock.
- □ Watch the video mentioned in the Hotsheet and call in, or report online, your LearningCenter[™] Form.
- Activate your debit card 72 hrs prior to the event using the instructions provided in this manual.
- Ensure that you bring the following items to your demo: Entire kit contents, demo table, pen (to complete paperwork), paperwork, tape, small trash can or bag, allergen & ingredient sheet.





Pop-Up Cooler Set Up Instructions




PUSH DOWN TO POP OPEN

Step 1: 72 Hours Before the Demo -Activate your card by calling

1-866-666-2587. When you call,

have the following information:

- Project # Found on your PromoReports
- Store # Promo Form
- PromoReport Code
- Your Debit Card Number (see card)

Step 2: Day of the Demo -Sample Product Purchase

On the day of the demo, purchase your sample product(s) using your PromoWorks Disposable Debit Card.

Remember, you will need to know your 4-digit PIN number (9991) to complete the purchase.

Step 3: After the Demo - Dispose Card

Dispose your PromoWorks Disposable Debit Card upon completion. This card will no longer be active.
