Sample Instructions

Please note: You will NOT be purchasing the refreshe electrolyte Fruit Essence water or ice. This will be credited back to the store internally via ROWSAP. Should store personnel have questions regarding ROWSAP, show attached Inter office Communication. This information applies ONLY to store personnel.

Arrive on time for your demo! Please set up your table as shown on the first page of this manual.

Special K Popcorn Chips & Special K Cracker Chips

- Purchase (2) boxes of Special K Cracker Chips Honey BBQ and (2) boxes of Special K Popcorn Chips - Kettle Corn Sweet & Salty using the debit card that you received in your kit. You will purchase the remaining boxes halfway through your event, if needed.
- 2. Open up a box of Special K Cracker Chips Honey BBQ. Place two chips on a napkin and set neatly on your table.
- 3. Open up a box of Special K Popcorn Chips Kettle Corn Sweet & Salty. Place two chips on a napkin and set neatly on your table.
- 4. Actively engage approaching consumers and offer them a sample along with a money-saving coupon. Use enthusiasm to recite the product features and benefits and to get the consumers excited about the product you are promoting. Replenish as needed.

refreshe electrolyte Fruit Essence Water

- 1. Request assistance from the Grocery Department Manager to obtain the refreshe electrolyte Fruit Essence Water product listed on page 1, as well as 1 bag of Safeway ice (UPC: 21130-08910, 4-40010-04201, or 4-40010 -00901). This product and the Safeway ice will be credited back to the store internally via ROWSAP.
- 2. Immediately chill refreshe electrolyte Fruit Essence product with ice.
- 3. Pour about 2oz into your sample drinking cups and place in front of the same flavor bottle on your table. *Limit the amount of samples poured when traffic is slow as it is best to sample chilled.*
- 4. Actively engage approaching consumers and offer them a sample. Use enthusiasm to recite the product features and benefits and to get the consumers excited about the product you are promoting. Replenish as needed.
